We have served as Maryland counsel to Host Hotels & Resorts, Inc., a Maryland corporation (the "Company"), in connection with certain matters of Maryland law arising out of the registration of 37,209,303 shares (the "Shares") of common stock, par value \$.01 per share (the "Common Stock"), of the Company covered by the above-referenced Registration Statement, and all amendments thereto (collectively, the "Registration Statement"), as filed by the Company with the United States Securities and Exchange Commission (the "Commission") under the Securities Act of 1933, as amended (the "1933 Act"). The Shares may be issued from time to time to the holders of the 2.50% Exchangeable Senior Debentures (the "Debentures") due 2029 of Host Hotels & Resorts, L.P., a Delaware limited partnership ("Host L.P.") upon the exchange of the Debentures, named in the Prospectus Supplement (as defined below).

In connection with our representation of the Company, and as a basis for the opinion hereinafter set forth, we have examined originals, or copies certified or otherwise identified to our satisfaction, of the following documents (hereinafter collectively referred to as the "Documents"):

1. The Registration Statement and the related form of prospectus included therein;
2. The Prospectus Supplement (the "Prospectus Supplement"), substantially in the form to be filed by the Company with the Commission pursuant to Rule 424(b) under the 1933 Act;
3. The charter of the Company (the "Charter"), certified by the State Department of Assessments and Taxation of Maryland (the "SDAT");
4. The Bylaws of the Company, certified as of the date hereof by an officer of the Company;
5. The Thirty-Second Supplemental Indenture to Amended and Restated Indenture, dated as of December 22, 2009 (the "Supplemental Indenture"), among Host L.P., the Company, the Guarantors and The Bank of New York Mellon, as Trustee, to the Amended and

Restated Indenture, dated as of August 5, 1998 (the "Base Indenture" and, together with the Supplemental Indenture, the "Indenture"), by and among HMH Properties, Inc., the guarantors named therein and HSBC Bank USA (f/k/a Marine Midland Bank), as trustee;

6. Resolutions adopted by the Board of Directors of the Company (the "Resolutions"), relating to, among other matters, the issuance of the Shares upon exchange of the Debentures, certified as of the date hereof by an officer of the Company;

7. A certificate of the SDAT as to the good standing of the Company, dated as of a recent date;

8. A certificate executed by an officer of the Company, dated as of the date hereof; and

9. Such other documents and matters as we have deemed necessary or appropriate to express the opinion set forth below, subject to the assumptions, limitations and qualifications stated herein.

In expressing the opinion set forth below, we have assumed the following:

1. Each individual executing any of the Documents, whether on behalf of such individual or another person, is legally competent to do so.

2. Each individual executing any of the Documents on behalf of a party (other than the Company) is duly authorized to do so.

3. Each of the parties (other than the Company) executing any of the Documents has duly and validly executed and delivered each of the Documents to which such party is a signatory, and such party's obligations set forth therein are legal, valid and binding and are enforceable in accordance with all stated terms.

4. All Documents submitted to us as originals are authentic.
